V. Town Administrator Report

Mariah Prescott reported that at the November Town Hall meeting the Mayor and Board voted in favor 2 to 1 for the recommended zoning amendments with an overall square footage cap of 15,000 square feet in the new Town Center-Mixed Use Zone. She also reported the proposed short-term vacation rentals Ordinance would be discussed with a public hearing at the next Town Hall meeting in December.

VI. Communication from Chair and Commissioners

Tim Hancock explained the difference between footprint and overall square footage cap that the Mayor and Board voted in favor of at the November Town Hall meeting. Tom Bartoo asked that all the articles in the proposed Design Standards in the packet be read through for the future readings.

VIII. Unfinished Business

a. Request to rezone 2902 Taft Highway from R-1 to C-1

Discussion:

The 2902 Taft Hwy rezoning application does not match the new Walden Land Use Plan Place Type of Taft Highway Residential.

The applicant's Engineer Report showed no problems with stormwater runoff. Storm water mitigation would be installed depending on what is developed on the property.

b. Recommendation for the Walden Planning Commission to serve as the Design Review Board

Discussion:

Tom Bartoo recommended that the Mayor and Aldermen search for a Design Review Board, and the Walden Planning Commission serve as the Design Review Board for 1 year as a fall back if the Mayor and Board do not appoint one by the time the Design Review Standards are ready for approval.

Tim Hancock pointed out that Walden does not have a process in place if there is an application in the new TC-MU and TC-R zones.

Tony Wheeler suggested that there should be a geotechnical review of the TC-MU zone if there is no member of the Design Review Board that has a member who is geologist.

Catherine Colby suggested the Design Review Board needs to be separate from the Walden Planning Commission.

Ashely Gates stated that the Design Standards must be reviewed and adopted by the Design Review Board after appointed. They cannot be adopted by the Planning Commission.

Motion to recommend the Walden Planning Commission to temporarily serve as the Design Review Board for 1 year with Tom Bartoo's amendment: if the Mayor and Board have not designated a Design Review Board by the time the Design Standards are completed and ready to be reviewed and adopted, then the Walden Planning Commission would act as the Design Review Board for 1 year.
