**Section 4.** The Mayor and Recorder may transfer funds appropriated herein from one line item to another, as necessary without increasing or decreasing the total amount appropriated in each department.

**Section 5** No appropriation listed above may be exceeded without appropriate ordinance action to amend budget.

**Section 6** A detailed line-item financial plan shall be prepared in support of the budget, and is hereby attached as an exhibit of this budget.

**Section 7** All unencumbered balances of appropriations remaining at the end of the fiscal year shall lapse and revert to the respective fund balance.

**Section 8** The appropriations of this budget shall become the appropriations for the next fiscal year until the budget for the next year has been adopted.

This Ordinance shall take effect July 1, 2008, the public welfare requiring it.
