

ORDINANCE NO. 2017--317

AN ORDINANCE OF THE TOWN OF WALDEN, TENNESSEE REVISING CERTAIN PROVISIONS OF THE WALDEN MUNICIPAL CODE RELATING TO THE SALE AND CONSUMPTION OF ALCOHOL

WHEREAS, Title 8, Chapter 1 of the Walden Municipal Code contains provisions relating to the sale of alcoholic beverages as authorized by state law; and

WHEREAS, the operation of the Town's facility at the McCoy Farm and Gardens requires accommodation for special permits for the sale of alcohol beverages; and

WHEREAS, other appropriate venues for special permits for the sale of alcoholic beverages should be accommodated; and

WHEREAS, it is appropriate to make other necessary revisions to the municipal code to avoid internal conflicts relating to alcohol.

NOW, THEREFORE, BE IT ORDAINED by the Board as follows:

Section 1: That Title 8, Chapter 1, Section 8-101(1) of the Walden Municipal Code be revised by deleting the phrase "five percent (5%)" and substituting therefor the phrase "eight percent (8%)".

Section 2: That Title 8, Chapter 1, Section 8-102 of the Walden Municipal Code be revised by deleting the phrase "five percent (5%)" and substituting therefor the phrase "eight percent (8%)".

Section 3: That Title 8, Chapter 1, Section 8-106 of the Walden Municipal Code be revised as follows:

- a) By the deletion of the following language: Drinking in public prohibited. It shall be unlawful for any person publicly to drink alcoholic beverages or beer on any public street, public sidewalk or in any public park. (as added by Ord. #2004-242, Jan. 2005).
- b) By the addition of the following language: Special occasion regulations. The regulation promulgated by the Tennessee Alcoholic Beverage Commission for Special Occasion Permits at Section 0100-01-.07, Rules and Regulations of the State of Tennessee, as amended, is hereby incorporated herein by reference and made a part hereof for the purpose of the sale, service, and/or otherwise dispensing of alcoholic beverages under the terms and conditions allowed therein.

Section 4: That Title 11, Chapter 1, Section 11-201 of the Walden Municipal Code be amended as follows (deletions noted by strikethroughs, additions noted by bold text).

11-201. Drinking alcoholic beverages in public, etc. It shall be unlawful

for any person to drink, consume or have an open can or bottle of **container of beer (as defined in Section 8-206) or alcoholic beverage (as defined in Section 8-101(1))** in or on any public street, alley, avenue, highway, sidewalk, public park, public school ground or other public place **not authorized by a Special Occasion Permit for beer as allowed by Section 8-207(c) or a Special Occasion Permit for alcoholic beverages as allowed by Section 8-106. In instances where a Special Occasion Permit is not required, this provision is inapplicable to town properties subject to a lease which makes provision for the consumption of alcohol under circumstances described thereunder.**

Section 5. Effective Date. This ordinance shall take effect upon its publication, the public welfare requiring it.
