AN ORDINANCE TO GRANT APPROVAL OF THE ABANDONMENT OF A PORTION OF THE 300 BLOCK OF SYLVAN AVENUE, PURSUANT TO THE RECOMMENDATION OF THE CHATTANOOGA-HAMILTON COUNTY REGIONAL PLANNING COMMISSION, IN THE PETITION SUBMITTED BY SUSAN GRUWELL

WHEREAS, the Town of Walden, Tennessee hereafter does not claim any interest to the Right- of-Way and makes no representation as to the ownership of the underlying fee of the Right-of- Way; and

NOW, THEREFORE, BE IT ORDAINED, that this ordinance shall take effect upon its publication, the public welfare requiring it.
